PAPER TRAILER FIRE – MAY 8th

At 6:00 pm, Saturday evening, May 8th, a fire was reported at our paper trailer site. AFD, Station 1 responded and found the trailer engulfed in flames. Fire was extinguished and damage was contained to the trailer and contents. No one was injured and the surrounding properties and buildings did not sustain any damage. Cause is underdetermined. Ames GK Board of Directors has appointed an ad-hoc task force with Tom Baas and Jim Penney, co-chairs, to develop a plan for clean-up, restoring our paper recycling project with Mason City Recycling, and developing any additional security measure to ensure that any future similar incidents will not occur. Committee will report to BOD within 60 days. In the meantime, all paper collection activity will be discontinued.
