Fire was extinguished and damage was contained to the trailer and contents. No one was injured and the surrounding properties and buildings did not anv Cause sustain damage. is Ames GK Board of underdetermined. Directors has appointed an ad-hoc task force with Tom Baas and Jim Penney, co-chairs, to develop a plan for clean-up, restoring our paper recycling project with Mason City Recycling, and developing any additional security measure to ensure that any future similar incidents will not occur. Committee will report to BOD within 60 days. In the meantime, all paper collection activity will be discontinued.
