

Board Minutes April 8, 2021 ZOOM Meeting

The meeting was called to order by President Keith Folkmann at 10:10 am, with members participating by ZOOM.

- 1. Stash-the-Trash. Mark Lohafer reported that 20 members have sighed up to help clean-up Brookside Park tomorrow starting at 9:00 a.m. Gene Pollmann and Mark visited Story County Engineer's Office to sign GK Club up for 2-mile roadside cleanup adjacent to Holub Greenhouse.
- 2. Membership Committee Report. Bob Sperry sent a written report. Retention game is going okay and will end in April. New Membership packet has been prepared and will be used extensively once in-person meetings resume.
- 3. Fundraising Committee Report.
 - a. "Dine to Donate." Scott updated the Board on the plans for the April 27th program jointly sponsored by GK and Texas Roadhouse. Welcome table will be used to distribute GK materials and provide a "tip jar" for donations.  - e. Member donations to meet \$14K budget. No change from previous month. Likely need around \$6K to mee our goal.
